

Yesterday, I was privy to news from various sources including from numerous National English TV and News Media Outlets, which had been carrying the disturbing news that in fact it was Animal Fat content mixed in the famous Laddu prasadam of TTD, Tirumala, AP. In this context, I am to state that the Directors of the company to whom the Company was awarded the contract after Nandinee foods – of Karnataka State Government was delisted (KMF)– was awarded to AR Diary Foods Private Limited and Kanagadhara Foods based at Dindigul and Coimbatore, Tamil Nadu.





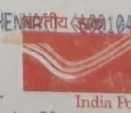
